Regional Background

The Southeastern Regional Planning and Economic Development District (SRPEDD) continues its support and assistance to the Southeast Regional Homeland Security Advisory Council (SRAC) in their efforts to develop, review, and approve planning, training, exercising, and specialized equipment projects. The SRAC serves ninety-seven cities and towns and has provided millions of dollars in U.S. Department of Homeland Security funding to communities since 2004. The SRAC serves as the policy-making body of the Southeastern Region Homeland Security Planning Region. The Council has members representing all relevant public safety disciplines including law enforcement, fire service, emergency management, local public health, hospitals, emergency medical services, public works, transportation, corrections, and local government administration.

The overarching role and responsibilities of SRAC is to develop a regional Homeland Security Plan and oversee all grant program expenditures. The Southeast Homeland Security Planning Region is defined by the Massachusetts State Homeland Security Strategy, which was developed by the Massachusetts Executive Office of Public Safety and Security (EOPSS) in 2004.

Through a series of surveys and conferences, stakeholders from all relevant public safety disciplines provided input on capabilities they felt needed to be enhanced and proposed trainings and exercises to address these capability gaps. With this information, a comprehensive plan to enhance regional preparedness through training and exercises was created and various training and exercises have been initiated and completed as a result.

SRPEDD, with the guidance and support of SRAC, continues to focus on expanding interoperable communications, improving emergency sheltering and community preparedness, enhancing tactical and technical rescue response capabilities,

supporting the regionalization of emergency assets, enhancing Cybersecurity, enhancing soft targets/ crowded places, enhancing information- and intelligence-sharing and cooperation with federal agencies, combating domestic violence extremism and addressing emerging threats.

The SRAC developed the FFY 2023 Regional Homeland Security Plan to detail regional goals and priorities over the next twelve to twenty-four months using the FFY 2023 State Homeland Security Program (SHSP) grant funding originating from the U.S. Department of Homeland Security (DHS). Project descriptions and budgets for all of the proposed FFY 2023 investments are included within this plan.

Accomplishments

Homeland security grant funding over the past several grant cycles has helped the region advance the National Preparedness Goal and strengthened the region in mission areas related to prevention, protection, mitigation, response, and recovery, through the following:

- Strengthened and supported the sustainability of regional Law Enforcement Councils (LECs) with additional SWAT tactical equipment and trainings such as Crisis Negotiation Training, Hostage Rescue Training and NYTOA Conference;
- Enhanced regional Technical Rescue teams' capabilities via continued training courses and the procurement of equipment;
- Measured Technical Rescue team member operational readiness and response via Structural Collapse Rescue Training, Medical Specialist Operations Training, Collapsible Structure Training, HazMat Toxic Medic Training, purchased Joint Hazardous Incident Response Team equipment;
- Continued expansion throughout Southeastern Massachusetts of the Boston Area Police Emergency Radio Network (BAPERN) radio interoperability project and continued to work on build-out of Phase III and IV of this project, Hired an Interoperability Engineer;
- Continued development of regional emergency sheltering equipment, such as purchasing two Family Assistance Center trailers (FAC), FAC trailer supplies, Inflatable Air Shelter and development of a Regional Shelter Plan;
- Enhanced Cybersecurity by holding multiple virtually based Cybersecurity Awareness Training webinars via partnership with three other state Homeland Security Advisory Councils for municipal officials and stakeholders throughout the Commonwealth;
- Enhanced Cybersecurity via partnership with three other state Homeland Security Advisory Councils for a Regional CISO Feasibility Study.

FFY 2023 Plan Development

The SRAC works continuously with a broad spectrum of stakeholders at various levels of government to develop, review, and approve planning, training, exercising, and specialized equipment projects. Over the last several months, the Council has focused on several priorities that include expanding interoperable communications, improving emergency sheltering/community preparedness, enhancing tactical and technical rescue response capabilities, and supporting regionalization of emergency assets. The review of FFY 2021 and FFY 2022 projects was considered in formulating the FFY 2023 Plan. As a result, the SRAC has decided to continue to fund these priorities with FFY 2023 grant funds.

Over the last several years, the SRAC has concentrated on high-priority and phased projects as a cautious means to do more with less funding. Funding priorities have been provided to Fire Services/ Technical Rescue and Law Enforcement Councils for sustainment and maintenance of their collective capabilities. Additionally, many of these projects are directly attributable to AAR recommendations.

The FFY 2023 Plan contains a continuation of priorityphased projects that are associated with FFY 2021 and FFY 2022 funding year projects. These projects include:

- Supported funding for the New England Crisis Negotiation Conference (NECNA), National Tactical Officers Association (NTOA) SWAT Training, and SWAT Hostage Rescue Training (HRT).
- Fire Services and Law Enforcement specialized teams will continue to receive funding to sustain and enhance their team readiness and ability to be deployed; ability to be responsive to both planned events and catastrophic, unplanned events as they warrant/require.
- Sustain the readiness and deployment of various

teams by providing ongoing training to Technical Rescue and LEC personnel and to fulfill their equipment needs and prepare to respond to evolving changes in current events across the Commonwealth.

- Provide multi-disciplinary training for disaster response/recovery for first responders.
- Continue to replace and repair Council-funded assets deemed to be critical and necessary.
- Project management and administration funds for the sub-fiduciary to support the project proponents and SRAC Council members.

Projects included in this plan address identified risks and gaps in the latest Commonwealth Threat and Hazard, Identification and Risk Assessment (THIRA) and Stakeholder Preparedness Report (SPR) and align with the 2020-2023 Massachusetts State Homeland Security Strategy (SHSS).

The LEC Teams are the primary tactical law enforcement resources for a majority of SRAC communities and likely would be the first to respond to any sort of incident where an act or threat of violence was ongoing.

This project will provide LEC Team members with several equipment resources that will enhance their ability to bring acts or threats of violence to swift conclusions, including: hearing protection, communication headsets, gas masks, night vision monoculars/goggles, K-9 cameras, pole cameras, dive lights, and other associated SWAT equipment. These items will be used as tactical tools to improve incident response and responder safety and not as weapons.

Project Description

This project will go towards the purchase of a new 32-foot-long Command Post vehicle for the Metropolitan Law Enforcement Council (METROLEC) SWAT team. Currently, METROLEC SWAT is utilizing a 2004 Command Post vehicle with over 10,000 hours run-time on its internal generators. The command post has over 45,000 miles on the odometer. The command post would be equipped with modern technologies such as video recording equipment, cameras, flat paneled televisions, and a variety of communications equipment. The vehicle will respond to a wide variety of incidents for all first responders on a multijurisdictional level to assist in facilitating and enhancing radio communications during critical incidents during events involving accidents, terrorist attacks as well as man-made and natural disasters. This vehicle will be deployed to support law enforcement, fire services, and EMS personnel at local and/or national security events.

METROLEC is comprised of forty-four communities and responds to the most call-out missions out of any of the other three LEC teams in the SRAC region. The METROLEC Command Post vehicle directly supports the Boston Police Department. The vehicle is used yearly to support the Boston Marathon, Pan-Mass Challenge, the Plymouth Thanksgiving parade, and major sporting events at Gillette Stadium in Foxborough, MA.

Project Description

The purpose of this funding is to provide continuing support for an Intelligence/ Information Sharing Analyst position. The Intelligence Analyst is responsible for the continued development and management of the Southeastern Massachusetts Regional Intelligence program. This program has been developed to work in lockstep with all other public safety disciplines, including fire, EMS, public health, 911, police, emergency management, as well as the SRAC. The primary role of the regional intelligence program is to collect, database, analyze, correlate, and digest information and data collected through routine reporting and daily operations to identify trends, gaps and vulnerabilities, and support regional cybersecurity initiatives. Additionally, this program uses conventional methods to collect and digest OSINT, SIGINT, IMINT, and HUMINT to detect, predict, and prevent acts of terror or crime. This position provides direct, hands-on support to regional election officals in support of securing elections. This position is heavily involved with the intelligence aspects of cybersecurity and election security and will maintain close liaison with regional and state cyber security programs.

Project Description

This project will provide updates and repairs for the Field Comm 10 truck currently housed in Mansfi eld, Massachusetts and utilized throughout Bristol County. The mission of the FC10 vehicle is to directly improve the resiliency of communications to the community it is dispatched to in an emergency. This vehicle provides critical communications during emergency incidents up to and including terroristic events where traditional infrastructure could be compromised. This vehicle has been increasingly used by the Bristol County Fire and Police Departments as well as by Fire Services Technical Rescue Team members. This truck is outdated and needs hardware, software, radio, camera, and other technological device upgrades to include charging stations, battery replacements, mechanical, lettering and paint upgrades. FC10 directly ensures resiliency in critical public safety communications by providing the route diversity, redundancy, and the ability to rapidly restore communications if the primary assets are damaged. This vehicle supports community preparedness and the whole community by cross-training Community Emergency Response Team (CERT) members in use of the equipment on the vehicle. CERT members train to support the FC10 unit on catastrophic deployments and major call-outs.

Project Description

Funding will be used to host a tactical boat operators course, covering instructor costs as well as fuel costs. This training would be ran in accordance with the National Association of State Boating Law Administrators (NASBLA) Boat Operations and Training (BOAT) Program which is designed to enhance the country's port security capabilities by providing students with the knowledge and skills necessary to appropriately react to threats in the maritime community. Training offered will be the same tactics, techniques and procedures that the U.S. Coast Guard uses to train its boat operators, and will ensure seamless integration into security operations amongst federal, state, county, local and tribal maritime law enforcement officers and agencies. This is a five days course for up to 20 students. Slots would be split among the LECs which serve coastal communities.

Project Description

This project would procure four All-terrain vehicles (ATV) for use by the regional Search and Rescue teams. ATVs can provide rapid transport of victims or personnel in and out of a search area as well as assist with hasty searches of trails, rail beds, and fire roads. There are many ATVs in the region already housed within police and fire departments, but there are few designated specifically for search which can sometimes come with different equipment and outfitting needs. ATVs are also useful for scouting out areas and for providing support to other rescue teams.
